TERMS AND CONDITIONS FOR CAMPING IN PULAU UBIN

By clicking the "I Agree" button, I confirm my agreement to the terms and conditions of the camping permit as stated below:

In these terms and conditions, the following words shall have the following meanings assigned to them:

"Applicant" refers to the person who submits the application form, applying for permission to use the Camping Area for camping and where the context requires, refers to the Applicant whose application has been approved by NParks for use of the Camping Area for camping;

"Camping Area" refers to the camping area in a public park which has been approved by NParks for camping by the Applicant;

"Park" refers to the public park within which the Camping Area is held;

"Permit" refers to the permission granted to the Applicant for camping at the Camping Area.

- 1. The Applicant must be 16 years old and above and have a valid residential address in the Republic of Singapore.
- 2. The Applicant shall, at the time of application, provide the particulars of all occupants of his tent.
- 3. The Permit is non-transferable, and each Applicant is only allowed one tent under the Permit. A new Permit will only be issued after the expiry of an existing Permit.
- 4. The Applicant is allowed to camp for four (4) days per month.
- 5. The Permit must be prominently displayed outside the tent at all times.
- 6. For each day of the camp, the Permit shall be valid from 9 am on the first day of the camp to 9 am the following day.
- 7. The Applicant shall be present at the Camping Area at all times and shall not leave the tent unattended, except in an emergency.
- 8. The Applicant shall ensure that there is no use of open fire and/or naked flames, LPG cylinders, refillable gas cylinders, mobile kitchens, portable stoves, generators of any form, barbeques and/ or the burning of charcoal, or any other activity that involves fire or open flames within or outside the tent at all times.
- 9. The Applicant shall ensure that the Camping Area is kept clean at all times and that all refuse and waste are properly removed and disposed, failing which NParks reserves the right to engage a cleaning contractor and all costs and expenses incurred shall be recoverable from the Applicant.
- 10. The Applicant shall assume all risks in respect of loss, injury or damage to any person or property, including the Applicant, all participants invited by the Applicant, NParks and their respective properties which may arise as a result of or in connection with the Applicant's application and use of the Camping Area or Park, or the non-provision of the Camping Area by NParks for use by the Applicant.

- 11. The Applicant shall take good care of and shall not cause any damage or permit any damage to be done to the Camping Area and Park, or to any property, facility, tree or shrub belonging to NParks and shall make good and pay for any damage howsoever caused, including accidental damage caused by any act or omission of the Applicant or any person invited by the Applicant.
- 12. The Applicant shall be solely liable for, fully indemnify and hold NParks, its officers, employees and agents, to the maximum extent permitted by law, harmless from and against:
 - (a) all liabilities, damages, costs and expenses arising from any claims, demands, actions, proceedings, recoveries, judgment or execution, damages, costs (including legal costs on a full indemnity basis and/ or reasonable solicitor's fees), losses and expenses of any nature which NParks, its officers, employees or agents, may suffer or incur by, from or in connection with the Applicant's use or failure to use the Camping Area or any decision, or action of NParks; and/ or
 - (b) all loss and damage to the Camping Area or the Park, its adjoining or neighbouring premises and to all property therein howsoever caused, whether directly or indirectly by the Applicant or any participant, including without limitation all loss and damage caused by the use or misuse, waste or abuse of water, fire or electricity by the Applicant or any participant invited by the Applicant.
- 13. NParks reserves the right to remove any unattended tents and belongings, without prior notice being given to the Applicant.
- 14. The Applicant shall be responsible for ensuring that all participants invited by him comply with the terms and conditions herein, and with prevailing laws and regulations, including the COVID-19 (Temporary Measures) Act and its Regulations, as well as the Parks & Trees Act and its Regulations. Specifically, the Applicant shall adhere to the following safe management measures, as well as any other measures that the Applicant is required to comply with at law:
 - Ensure that all participants either check in with the TraceTogether app and keep their apps turned on, or bring their TraceTogether token.
 - Maintain records of participants and keep these records for at least 25 days after the activity.
 - Ensure that there is no intermingling with other groups.
 - Conduct checks for visible respiratory symptoms for the group and disallow any participant with a fever and/or who appear unwell from being at the Barbecue Pit or Park.
 - Ensure that all participants don masks, which can only be taken off during strenuous exercise, or when consuming food, drink or medication.
 - Camping tents must be at least 5m away from another tent to allow for activities and safe distancing.
 - Observe the signs and comply with instructions from our officers in the Park.
- 15. Under the Parks and Trees Act and the Parks and Trees Regulations, certain activities are prohibited unless otherwise approved by the Commissioner of Parks and Recreation. In particular, the Applicant acknowledges that:
 - No activities shall be conducted on footpaths, walkways, or access paths and there is no blocking of the same during any activities.
 - The use of sound systems is not permitted.

- Soliciting for a business purpose and exchange of cash for services is not permitted.
- Objects (including exercise equipment, banners etc.) must not be attached to our plants and structures.
- Activities which may cause inconvenience to other visitors, such as martial arts, are not permitted.
- The use of open areas is **non-exclusive**. There shall be no reservation or blocking of any areas from being accessed by other members of the public. NParks' approval shall not be construed as an approval for the exclusive use of any Camping Area or spaces within the Park.
- 16. NParks reserves the right to revoke the Permit granted and/or to immediately halt any activity which it deems necessary to do so, or to require all or any participants to immediately leave the Camping Area and/or Park if, in its opinion, any of the regulations herein have been breached, are breached or may be likely to be breached or if the activity may endanger or cause discomfort or inconvenience to other users of the Park. NParks also reserves the right to bar the Applicant from future Permit applications.
